

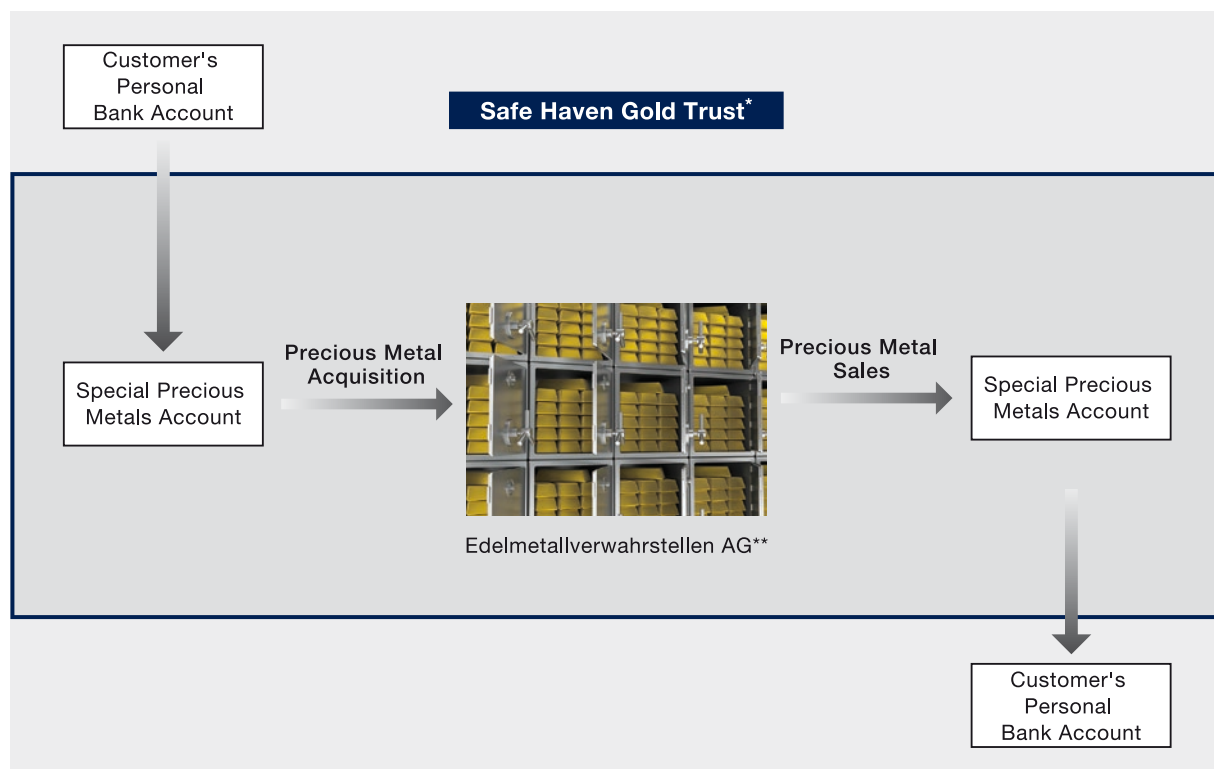
Loewen Precious Metals Portfolio

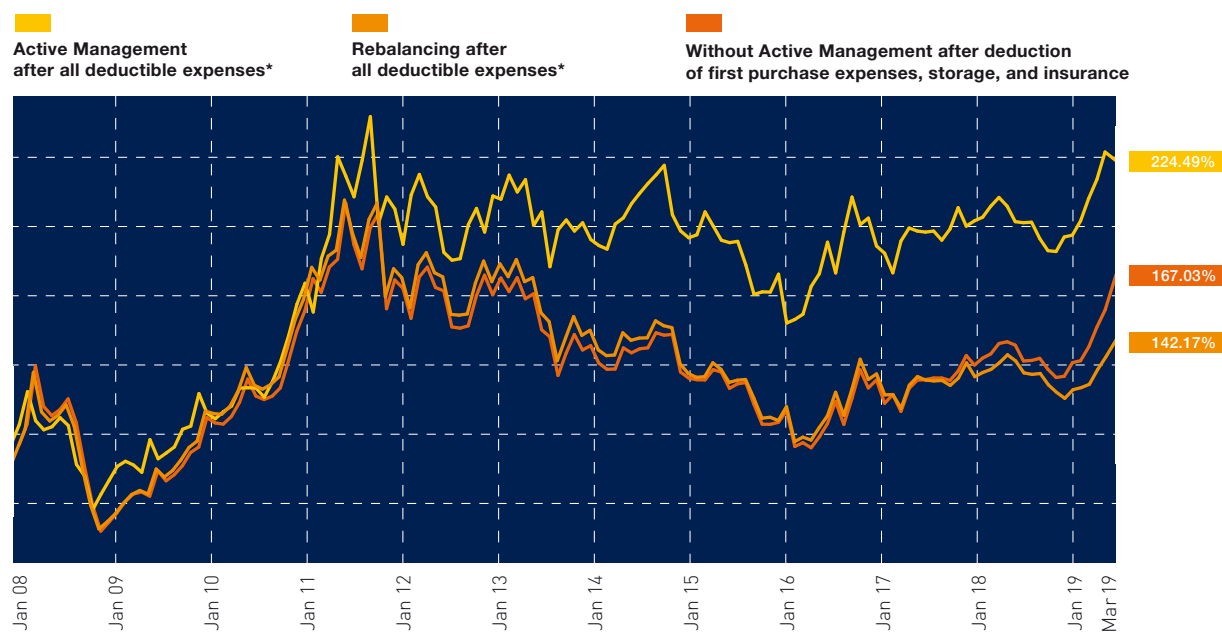
